 - o Perhaps less detail on activities, more description of how GA SLOs will work in course.
 - Matrix may not be best organizational structure for actual form, but example shows how course parts coordinate with LEP GA SLOs.
 - Discussed how courses may be created exclusively to fit LEP rather than begin as department-defined course first.
